OBTAINING A GRANT OF REPRESENTATION

Obtaining a grant of representation (Grant) – be it a Grant of Probate, Grant of Letters of Administration with the will or a Grant of Letters of Administration on Intestacy, is often the first step needed to administer the estate of a deceased person.

A Grant may be necessary to:

- Release funds from a bank or other financial institution
- Release a refundable accommodation deposit
- Protect the executor
- Settle a dispute regarding a will

The purpose of obtaining a Grant is to confirm the validity of the will (if there is one) and to confirm or convey authority on the person(s) named in the Grant to conduct the administration of the estate.

There can be great benefit in obtaining the Grant in a quick and efficient manner.

Fees for Services.

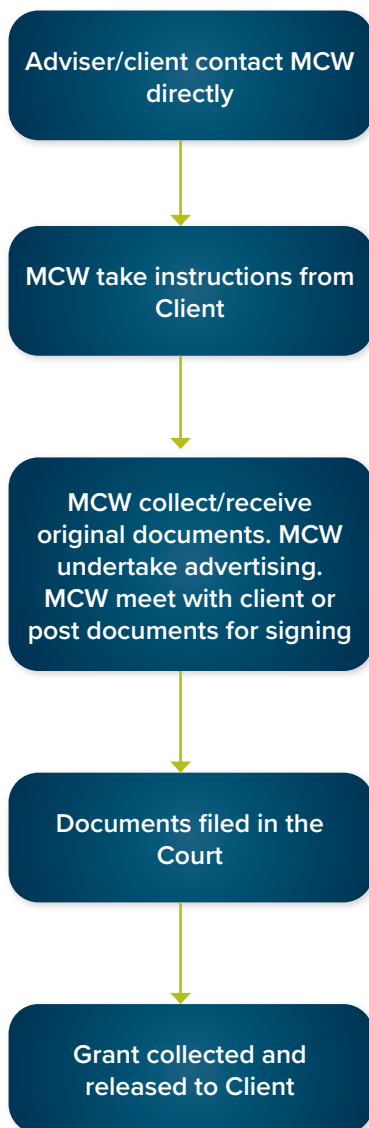
MCW always wants fees for legal services to be clear, up front and competitive.

MCW fee for a standard Grant is **\$1,500 plus GST and outlays.**

The hourly rate for an initial estate administration consultation, should it be necessary, is reduced to \$450 plus GST per hour.

Process.



Usual Steps.

- After contacting us, MCW will ascertain the client's needs and email or post a short retainer letter confirming the engagement and steps to be taken.
- Clients to forward the following documents to MCW:
 - Original will or signed [Authority to Release Documents](#)
 - Original death certificate (once received)
 - Copy of their identification
 - Completed [Client Information Sheet](#)
- Once the necessary original documents are available, MCW will arrange the necessary advertising and post or meet with the clients to sign the court documents.
- Once the advertising period (14 days) expires and the court documents have been properly signed, MCW will file all court documents in the Court.
- Once notified that the grant has issued MCW will collect the original document and notify the client.
- MCW is usually prepared to delay payment of fees until the Grant has issued from the Court. Typically payment of fees is required before the original Grant is released to the client. Other fee arrangements may be agreed.
